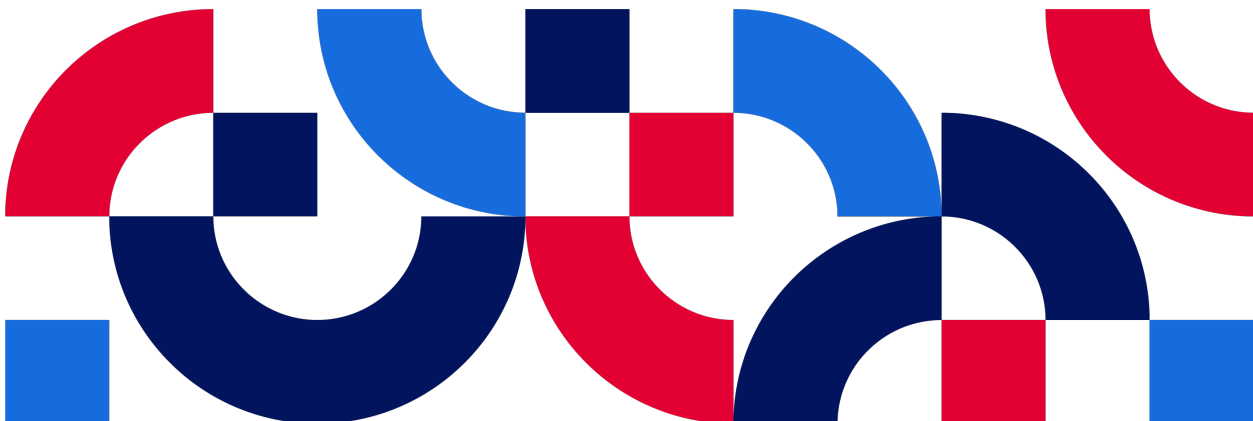

Question 1:

We understand we are to submit pricing for a 15,000 endpoint utility. However, it is mentioned more than once in the RFP that a multi-tenant solution is desirable. Our perception of the pricing exhibit model does not show this and only allows an example of single instance solution. How would HCI want us to frame the pricing for multi-tenant pricing?

Answer:
